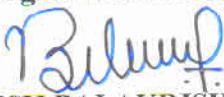

An audit also includes assessing the accounting principles used and significant estimates made by the management, as well as evaluating the overall financial statements presentation. SIGNIFICANT ACCOUNTING POLICIES :

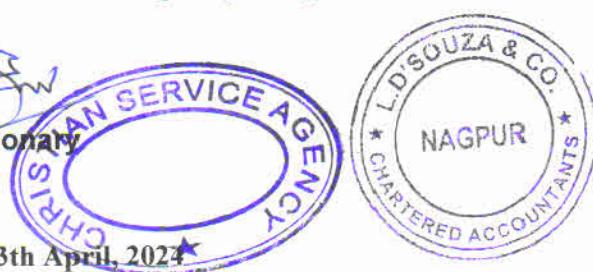
1. The accounts are prepared on historical cost convention.

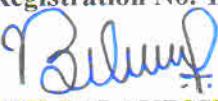

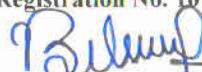

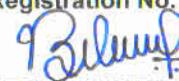
